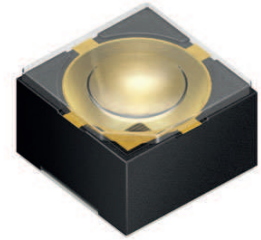

### Notes

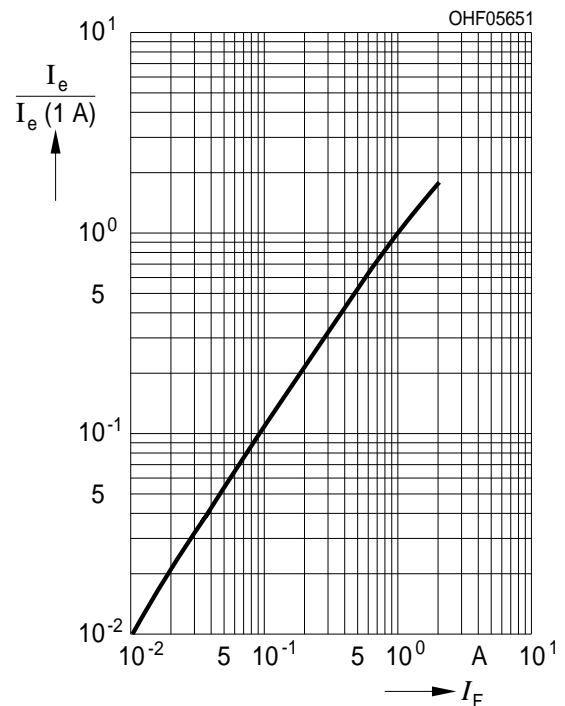

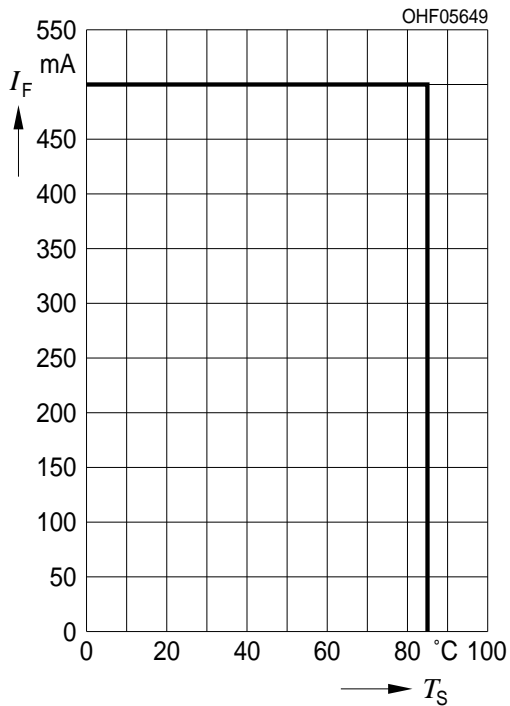

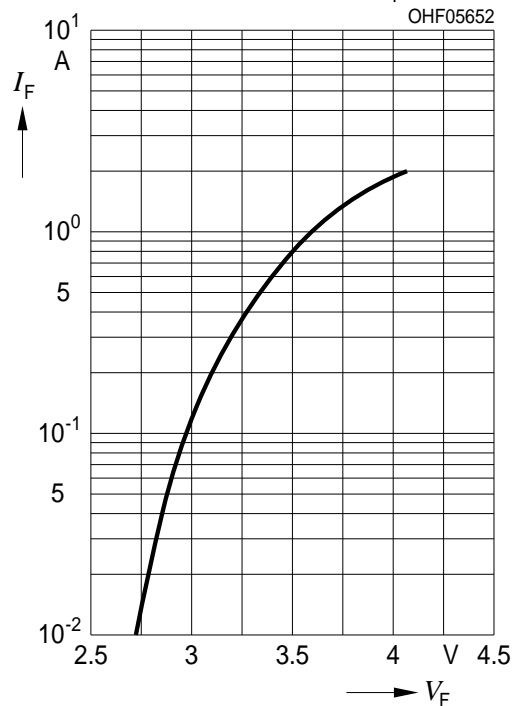

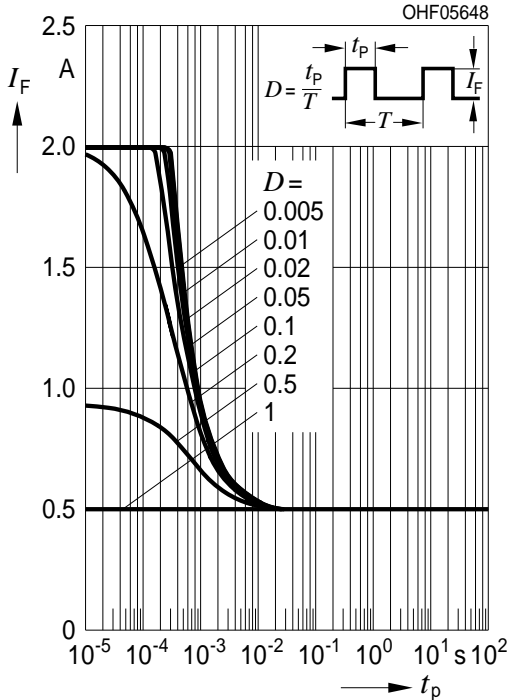

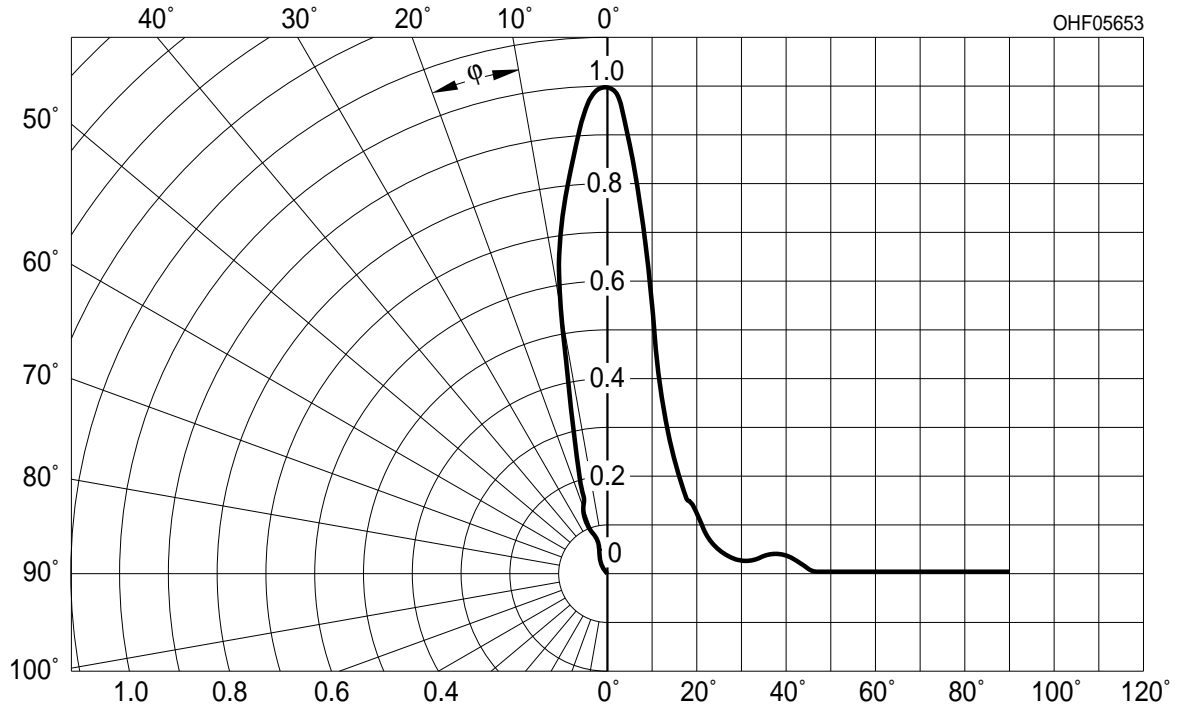

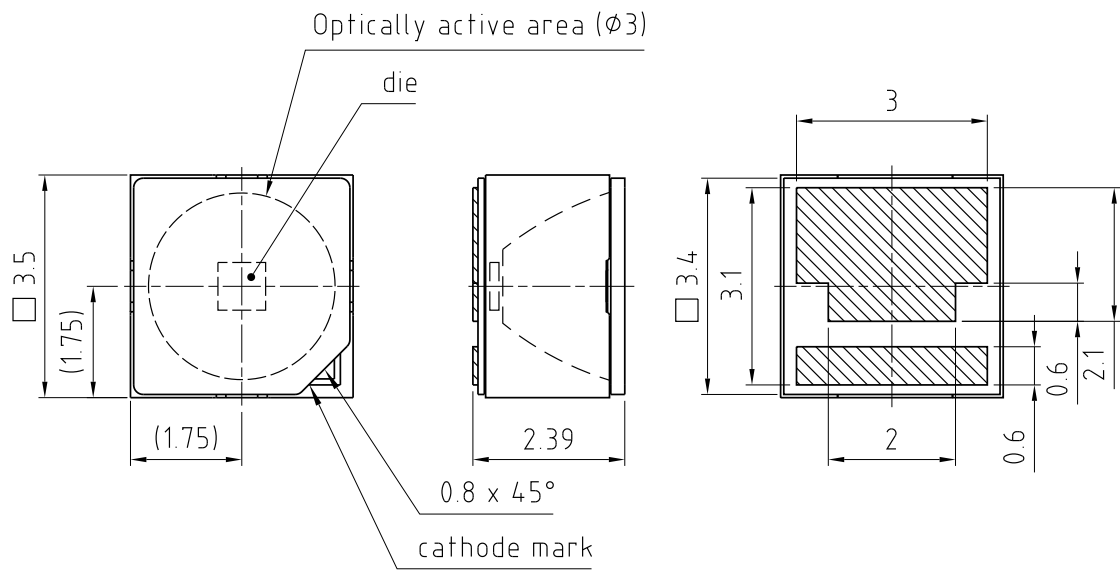
